**Re: Required Safety Warning  
Mandated by Act 119 of 2007**

**Act 119 of 2007 Required Warning  
This is a Must Do for all Propane Dealers**

According to Act 119 of 2007, titled "An Act to Provide Affirmative Defenses to LP Gas Providers in Actions for Civil Liability", Section 2 (b) (2) (B) there is a mandated requirement that a reasonable warning against the consequences of misusing LP equipment be given for new, used or current LP equipment or appliances. This can be accomplished by the original manufacturer's information that is provided in the case of the purchase of a new appliance or equipment by the customer, or by the LPG provider, namely you. The required warning is not limited to only new equipment or appliances but extends to the tank, plumbing, leaks and existing appliances.

In order for you to protect yourself and accomplish this requirement so that you will know that it has been done and can testify to that fact, an "Important Notice" has been written for your use and a sample is enclosed here. It is necessary for you to document the fact that you have provided this notice to your customers in any event, including to those that may have purchased new LP equipment or appliances. You can make it a habit of giving it out at all tank sets, all office visits and periodically, at least once a year, in a "flyer" or "mailer" or "bill stuffer" to all customers.

The Association has printed these notices and now has them on hand at cost plus shipping for your use. For blank notices the cost is \$70.00 per 500 and printed is \$80.00.

You may personalize the notice to include your company name and contact information by you using an office stamp in the space provided prior to giving out or by the direct printing of that information on the notice in that same space by our printer before shipping to you. Prices for both are shown. Proof that the customer received the notice from you is your name on that notice that is in their hands.

**This is nothing to be taken lightly. It is now an Arkansas Law  
that this type of notice is given and you should comply as soon as you can**
